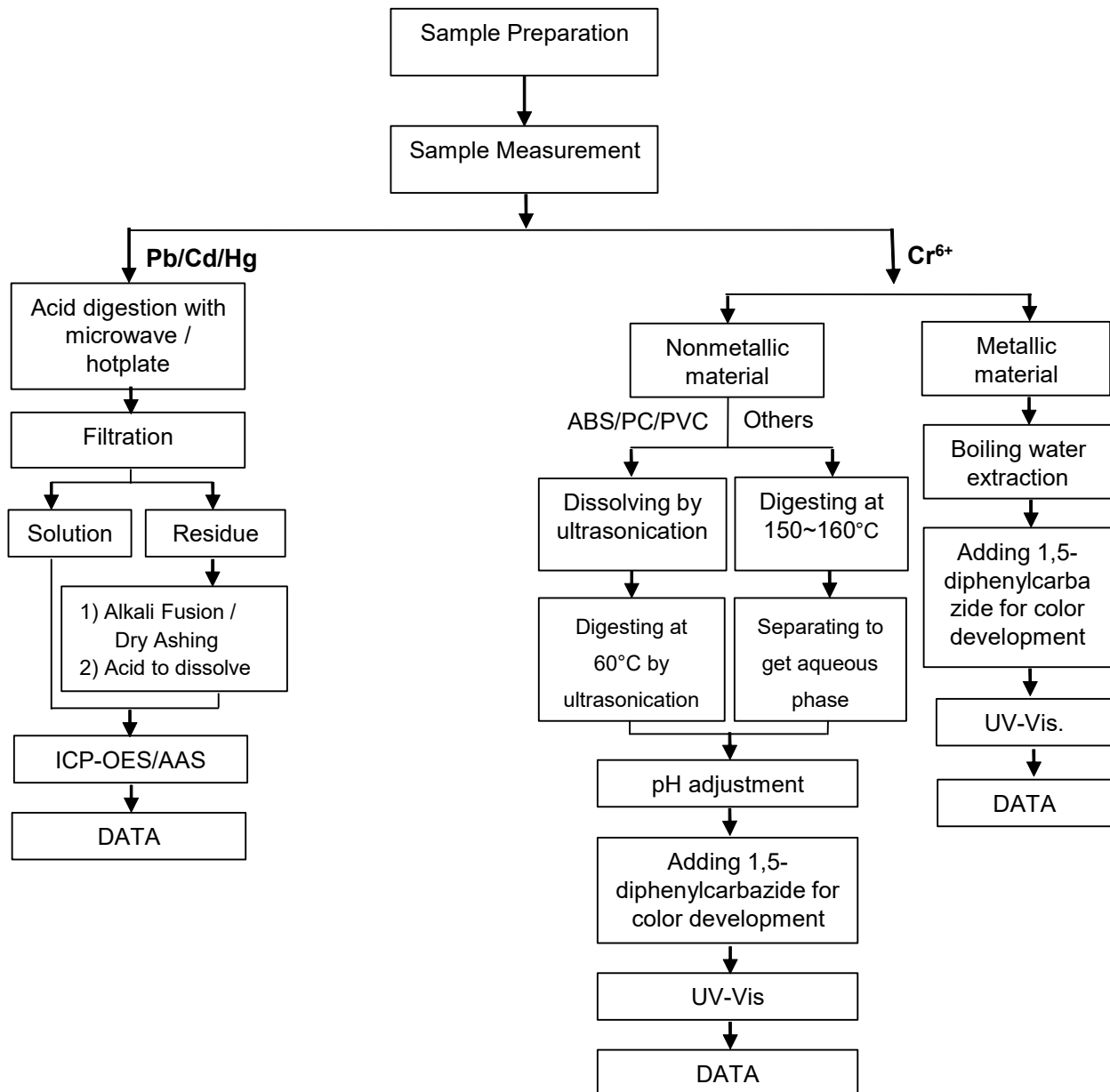

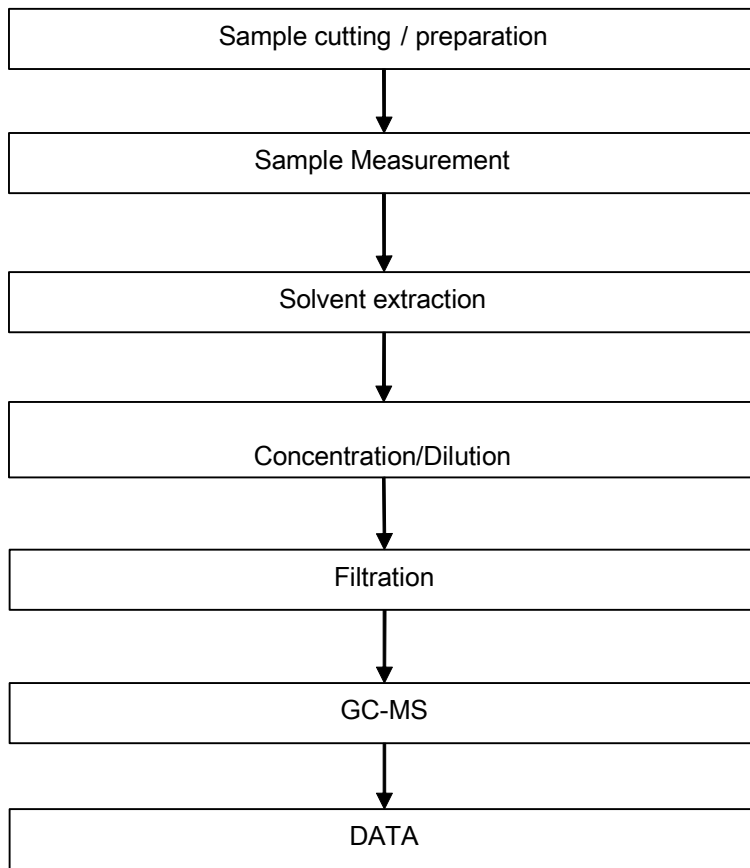

PBBs / PBDEs Testing Flow Chart



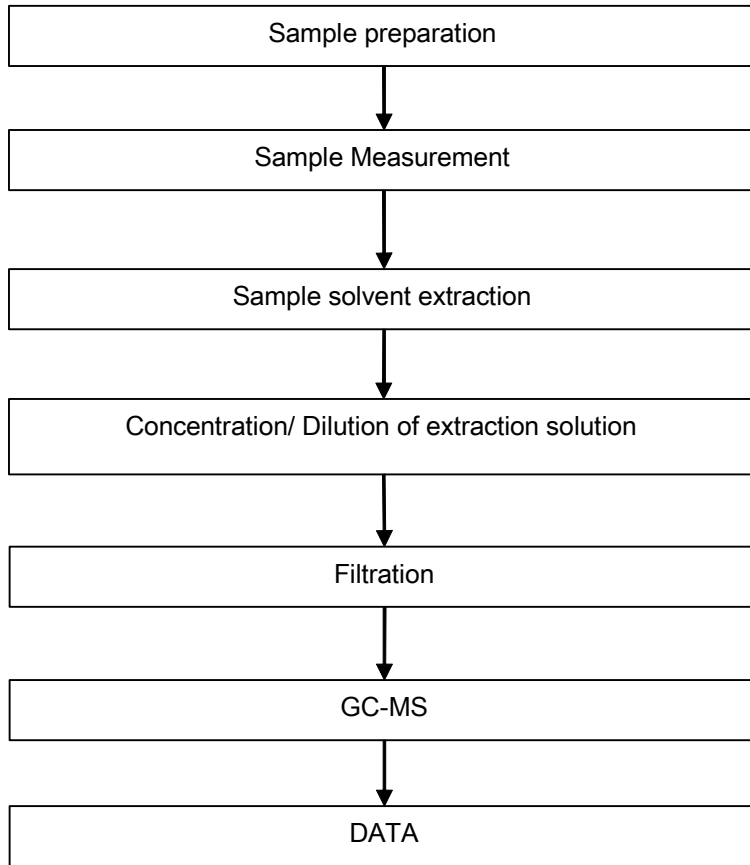
