1.0 INTRODUCTION

1.1 Welcome to mystaffgits.easy.co (the "Website"). Please read the following Terms of Service carefully before using this Website so that you are aware of your legal rights and obligations with respect to mystaffgits.easy.co, its affiliates and/or subsidiaries (individually and collectively, "mystaffgits.easy.co", "we", "us" or "our"). The "Products" we provide or make available include (a) the Website, (b) the products provided by the Website made available through the Website, and (c) all information, linked pages, features, data, text, images, photographs, graphics, tags (including, without limitation, any website services) or other materials made available through the Website or its related products ("voucher"). Terms and Conditions

2.0 Anti-Fraud Policy

2.1 We are committed to ensuring the security and integrity of transactions on our website. Continuous or repetitive purchases using (“identical”, “repetitive”, “similar”, and “duplicated”) payment details or bills may be flagged as potentially fraudulent. We reserve the right to investigate and take necessary actions to maintain a safe transaction environment. We have the absolute right to restrict or terminate your account, neglect or restrict your current and future purchases in our website until further notice, or take legal action upon potential fraudulent.

3.0 Account Review and Suspension

3.1 If your account is flagged for suspicious activity, including repetitive transactions using the same payment details, we reserve the right to conduct a thorough review of your account. During this review period, your account may be temporarily suspended or restricted to prevent further transactions. Based on our findings, we may either reinstate or permanently deactivate the account at our sole discretion. Similar payment details by different accounts shall be deemed as suspicious and we shall hold the right to neglect the purchases made by the account. In such cases, no compensation and refunds will be provided to these accounts that are deemed suspicious.

4.0 Right to Cancel or Void Transactions

4.1 We reserve the right to cancel or void any transaction at our discretion if there is reasonable evidence or suspicion of misuse, abuse, or fraudulent activity. Misuse may include, but is not limited to, actions that circumvent our purchase limits, exploit promotional offers, or involve repeated use of the same payment details for continuous purchases in a manner inconsistent with our policies. In such cases, no compensation and refunds will be provided for transactions that are deemed invalid.

In such instances, we may:

- **Temporarily suspend** the transaction while we investigate the activity to determine its legitimacy.
- **Permanently void** transactions deemed fraudulent or abusive, with no obligation to provide compensation, refund, or replacement for any voided transactions.
- **Suspend or deactivate** the associated user account(s) as necessary to prevent further violations of our terms.

4.2 Any attempts to dispute these decisions without evidence of error or unjust treatment will not be entertained. For questions regarding specific cases, you may contact our support team; however, the final decision on all transactions remains with mystaffgits.easy.co.

5.0 Privacy Policy

5.1 Privacy Policy explains how we collect, use, disclose, and safeguard your personal information when you visit our website, use our services, or interact with us. We value your privacy and are committed to protecting your personal information. By accessing our website or using our services, you consent to the practices described in this Privacy Policy.

5.2 Information We Collect

We may collect personal information that you provide directly to us when you interact with our website or use our services. The types of personal information we collect may include, but are not limited to:
